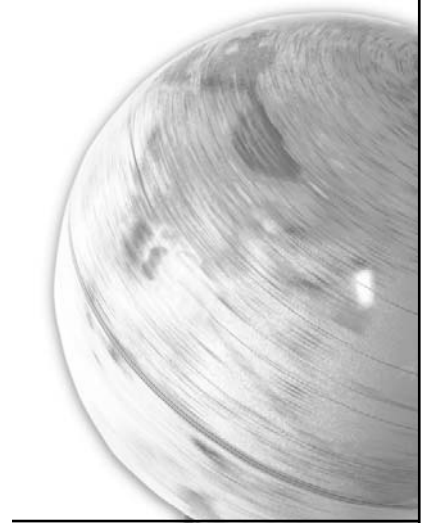


# Acknowledgements
