Health Care Reform

- **Most eligibility provisions effective 1/1/14**
- **Affect Medicaid and NCHC**
- **New Enrollment**
 - Currently eligible, but not enrolled
 - Newly eligible
- **Interface with Exchange**

Application-Automation and Streamlining

- **Individuals/families** - can apply through DSS or Exchange
- **Apply: Current**
 - In-person
 - Mail
- **Apply: ACA**
 - Electronically
 - In-person
 - Telephone
 - Fax
 - Mail

Applying for Medicaid/NCHC

- **Single streamlined application for Exchange Tax Credits and Medicaid/NCHC**
 - CMS in process of developing model application
 - Applies to paper and electronic
 - States can develop alternative application - must be approved by DHHS Secretary
 - Cannot ask for information not required for MAGI determination up front
 - If not eligible for MAGI group, can collect additional info for other eligibility groups

Eligibility Determination

- As automated as possible
- Rely on data matches to extent possible
 - Federal Hub
 - Other matches
- Medicaid must still use current income - not most recent tax year

Enrollment and Eligibility

- **New formula for determining financial eligibility**
 - MAGI (modified adjusted gross income)
 - Must convert current FPL income limits to MAGI equivalents
 - No deductions allowed except 5%
 - Does not apply to age 65+ and Medicare beneficiaries
 - New eligibility policy and rules
 - Legislative changes
- **Eliminates asset test for new category and MAGI groups**

Enrollment and Eligibility (cont.)

- **Expands coverage for former foster care children to age 26 effective 1/1/14**
 - NC added optional coverage through 20 for foster children
- **MAGI and removal of asset test not applicable to:**
 - SSI Medicaid
 - ABD - age 65+ or recipients with Medicare
 - Medically needy
 - Medicare Savings Programs (MQB)

Current Work

- **NCFAST:**

- Medicaid/NCHC eligibility - review and simplification
- Developing rules engine for current Medicaid/NCHC
- Regular meetings for updates/information-sharing
- Phased Implementation
 - FNS - beginning February, 2012
 - Medicaid/WF/SA - beginning February 2013
 - Other programs added in subsequent years (Child Care, other services)

- **Identifying areas of potential change prior to 1/1/14**

- Assets for Family Medicaid group (MAF/HSF)
- Certification periods

Current Work, cont'd

- **Integrated Eligibility - Medicaid/NCHC, WF, FNS, Child Care, SA**
 - Ongoing project with the divisions (began in 2010)
 - Focused on income, resources and budgeting methods
 - Preparation for NCFAST and simplification
- **Reenrollment process -**
 - Ex parte for MIC/NCHC reviews - administrative process
 - Contact recipient only if info not available
 - Proposed regs suggest this for all Medicaid/NCHC
- **Extensive review of proposed regs**
 - Comments due by 10/31/11
